



## TOWN COUNCIL MEETING June 5, 2014

quorum being duly present, Council President Jessica Rapp Grassetti called the June 5, 2014, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Rapp Grassetti regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

### PUBLIC COMMENT:

Steve Luciani said his pet project is to upgrade the Centerville Recreation Park. The rules are too strong with the playgrounds. He replaced broken swings, made it look pretty, nice shady playground. Let me do my thing!

Elizabeth Wurfbain gave an update of the Main Street area. She referred to the group of volunteers that worked together to make Main Street Hyannis a pleasant place to visit, walk about and work.

Kris Clark listed many reasons to support the KorKuch property including: passive recreational usages, public access, and wetlands. Recommended by the Conservation Commission to purchase this property; please support this acquisition.

Mark Robinson expressed support of the KorKuch property. With the help of the State grant it is a good deal for the town and a worth endeavor.

Tom Mullen supports the purchase the Korkuch property; Mullen told the Councilors of the historic significance of this property.

Tom Lee urged the Councilors to vote for the purchase of this piece of property. Close public comment

Hebert thanked the Main Street group and the Police Department for their perseverance working towards a visitor friendly Main Street. People are making positive moves in the right direction.

Councilor W. Crocker thanked Mr. Luciani for volunteering his time and money to work on the islands and the park in Centerville.

Councilor Chirigotis thanked Steve Luciani for his work at the Centerville playground and with the Civic Association. Chirigotis thanked the BID for their work on Main Street, and suggested a new area of focus could be the vacant lot on Ocean Street.

Continuation of previous meeting

### **Councilor Discussion and Comment:**

Appreciates feedback; surprised we did not receive all the information in advance; need better process in place; pressure to make a decision when we were not prepared; few changes that came out of our delay period. Need clarity and an explanation of the contractual agreement. [Mr. Robinson, Director of the Compact of Cape Cod Conservation Trust, unpaved parking for five cars has been added to the contract.] Trail of the conveyance needs to be discussed; [The Barnstable Land Trust was awarded a Grant, to allow a conservation restriction on the property; that expires at the end of June. The price the Town would pay is 265,125.00 the Compact steps in to close the pending sale with the Korkuch family, then the Compact puts the conservation restriction in place and sells the land to the Town of Barnstable.] Sensitive to the paperwork regarding the title of the property, what we are voting on is the 265 payment and that is all we ever advertised. [Council and Manager typically approve both the purchase and the Conservation restriction.] We should

advertise that we are reviewing restrictions. Need to understand the restrictions before we go forward. Regarding page 12; [Dave Houghton discussed changing the word "approve" to authorize on the contract.] Frustrated with the process, could have been handled better all the way around. In March an email that was not sent to the Councilors; it included a large packet of information that was not shared with the Council; the process is a little neater when we hold the Conservation Restriction. A combination of miscommunications; lessons have been learned; consider a process, The Council should have seen this much earlier so that all the questions could have been asked and answered a long time ago. This relationship with the Compact has happened before. Okay with the change that was made; a historic property, shared with three active properties. Enough safeguards going forward; a lot of new faces on the Council; it was bulldogged through the system; too fast to spend that much taxpayer's money; [The town ends up with title after the Compact ends up with title...call it a flip] Quality of the title; [Dave Houghton stated there are issues with the title; the order provides that we obtain a clear title. We have retained an attorney that is a title expert.]

**ORDERED:** That the Town Manager is authorized to purchase on behalf of the Town the fee simple interest and all other rights, free from encumbrances, in real property pursuant to the Community Preservation Act, G. L. c 44B, for open space, shown on Assessors Map 299 as Parcels 055001 and 055002, further described as Lots 1 and 2 on plan entitled "Plan of Land in Barnstable, MA prepared for Kasmir Korkuch, Jr. Scale 1" = 60' June 12, 1996 and recorded in the Barnstable County Registry of Deeds in Plan Book 526, Page 68, including but not limited to an owners title insurance policy in the fee and all other interests in the amount of the purchase price with standard exceptions only; that pursuant to said G. L. c. 44B the sum of Two hundred sixty-five thousand one hundred twenty-five and NO/100 (\$265,125.00) Dollars be appropriated and transferred from the amount set aside for open space in the Community Preservation Fund for the purchase of said interests and rights free from encumbrances; and that the Town Manager is authorized to contract for and expend the appropriation for the stated purposes upon issuance of the aforesaid policy of title insurance, execute and record any written instruments, grant restrictions and accept any gifts or grants in relation thereto, subject to the oversight of the Community Preservation Committee.

Thomas Lynch, Town Manager introduced the Laura Cronin of the Comprehensive Financial Advisory Committee, she highlighted some of the items of the review. (Exhibit A)

#### **Councilor Discussion and Comment**

Great amount of detail; found this document very helpful; we need to see how to create new growth; would be happy to see some discussions on pilot programs; fire district issue biggest increases, shifting the tax burden to the commercial tax base; look at how the businesses handle these additional taxes; need to go deeper; appreciate the voice of the citizens; this report was more informed and organized; pilot programs are a great idea; every year we

hear about the enterprise funds; recommend ways to improve them; reach out and get as much feedback as possible from the citizens; thorough report, hit on many points we have made as a Council; fire district is frustrating; we are separate, independent and autonomous; not the effective forum; we collect the fire district bills; pilot program to look at services in place of payment; would be nice to have a workshop about the pilot programs; on the recommendation for the Airport did you have any legal consultations on that? [No, looked at it as an opportunity] Regarding Enterprise Funds would prefer that we spend down the surplus a little bit; instead of putting a burden on the back of the taxpayers; just to balance out. Wealth of knowledge on the CFAC; will be asking the CFAC to do a presentation in the near future.

Town Manager, Thomas K. Lynch, state the theme of the operating budget to "build on our strengths." Lynch illustrated the budget plan with a power point presentation:

Why did we change the location from the High School to the Intermediate School [The Intermediate School is a pet friendly shelter which was a major concern] please indicate to the people at home where the Intermediate School is located [Route 28, directly to the rear of the High School] thank you for the changes in downtown Hyannis area.

Comprehensive presentation; clarify a few items; personnel expenses this is just salary and wages only [Correct below the national average] seeing a shifting of personnel to meet the student needs. teachers are providing the services; [total increase representing contractual increases] cost of an ell teacher versus assistant ell [40,000 versus half that cost for an ell assistant] thank you for the hard work that went into this: crossroads programs. Tuition to other schools is about 12%, what is that equated to in costs [4.9 million dollars] increase of children at the elementary level; How many of these students are ell services [educating and giving them the basics and then we are losing them] any way to share the expense for the ell students with other schools [that would never happen] program changes comprised of: [figure for contractual employees] busing issues [to prepare, own and house the buses would be very costly] who gets left behind [middle students working on targeting those students] how are we going to fund the transportation costs going to jump [using the surplus as it goes down, then we will level off and pay for itself lot of people opt to drive their kids rather than pay the fees for buses [presentation of all fees in July] we are obligated to educate a child, they only need to be a resident of the town, however they do not have to be a citizen; always available and committed to the people of this Town. Teacher retirements, has the district thought about retired teachers health insurance [building leadership, getting quality candidates] benefits for retiring teachers [Mark Milne, we have established a trust fund to address this issue of retiree healthcare benefits] grade 6 English and Math, how would these be effected by common core [movement to common core is more difficult testing] green card holders are tax pavers; leasing arrangements with Cotuit that those monies go back into those schools [Mark Milne special revenue funds to save that money to go back into those schools] follow up with students coming to our schools from China[next week meeting with the Superintendents from the Global Initiative]
