## Appeal No. 2013-076 - Traywick

# Chapter 40B Comprehensive Permit

Martin Traywick has applied to the Zoning Board of Appeals for a Comprehensive Permit pursuant to MGL Chapter 40B and in accordance with Section 9-15 of the Code of the Town of Barnstable, the "Accessory Affordable Apartment Program." The applicant is seeking to convert five existing apartments within a multi-family dwelling into accessory affordable units in accordance with all conditions of this permit. The issuance of this permit would allow for five affordable accessory apartments within a multifamily dwelling. The property is addressed 525 Ocean Street Hyannis, MA and is shown on Assessor's Map 324, as Parcel 048-001. It is in RB-Zoning District.

- The Public Hearing was opened on April 23, 2014, 2014 at 6:00 p.m. by the Hearing Officer Craig G. Larson.
- The applicant Martin Traywick was present at the hearing.
