**Appeal No. 2018-031**

**Peacock**

Michael Peacock applied for and was granted a Comprehensive Permit under Chapter 40B of the General Laws of the Commonwealth of Massachusetts, and in accordance with Article II of Chapter Nine of the Code of the Town of Barnstable. Michael Peacock no longer wants to participate in the Program so therefore Comprehensive Permit No. 2018-031 must be rescinded. The subject property is addressed 1548 Santuit-Newtown Road, Cotuit, MA as shown on Assessor's Map 024 as Parcel 015. It is zoned Residence F.

**Procedural & Hearing Summary:**

A public hearing to rescind Comprehensive Permit No. 2018-031 was duly advertised and notice sent to abutters and the property owner all in accordance with MGL Chapter 40A. The hearing was opened on March 26, 2025 at which time the Hearing Officer, Jacob Dewey, made the following findings and decision:

**Findings of Fact:**

1. The Applicant, Michael R. Peacock, was granted Comprehensive Permit No. 2018-031 for an Accessory Affordable Apartment at 1548 Santuit Newtown Road, Cotuit, MA.
2. The Applicant, Michael R. Peacock, does not wish to participate in the Program.
3. On February 6, 2025, the Accessory Apartment Program Coordinator took action to rescind Comprehensive Permit No. 2018-031.

**Ordered:**

Comprehensive Permit No. 2018-031 is rescinded.

A written copy of this decision shall be forwarded to the Zoning Board of Appeal as required by the Town of Barnstable Administrative Code Chapter 241, section 11. If after fourteen (14) days from that transmittal the Members of the Zoning Board of Appeals takes no action to reverse the decision, this decision shall become final and a copy shall be filed in the office of the Town Clerk.

Appeals of the final decision, if any, shall be made to the Barnstable Superior Court pursuant to MGL Chapter 40A, Section 17, within twenty (20) days after the date of the filing of this decision in the office of the Town Clerk. The applicant has the right to appeal this decision as outlined in MGL Chapter 40B, Section 22.
