F1218-01 Review & Approve Hyannis Air Service Collateral Access Agreement- 600 Barnstable Road.

- The Finance Subcommittee and Commission approved the Collateral Access Agreement for their 660 Barnstable Road in August 2018. Their bank is asking they have one also signed for the other building they lease from the Airport at 600 Barnstable Road.

F1118-06 Review & Approve Updated Airport Air Carrier Incentive Program.

- Manager Servis stated the existing program has expired. She will be preparing a draft version to be sent out to the commissioners this week
- The following bullet points were discussed:
 - Category 1: Incentives we need to update tables to reflect current fees.
 - Category 1: Eligible Services we would like to take out the language "nonstop" flights. This language limits us to just the airlines.
 - Category 2: Eligible Services change the language "at least two nonstop flights a day" to one nonstop flight a day.
