- Then he will brainstorm concepts, create a selling strategy, and return to the Commission with a reporting of information
- He will be attending a meeting on Nantucket April 20th with Airport Management to strategize for regional service.

 - State Fire Marshall inspection has been scheduled.
 - The fencing is being installed, there has been a delay obtaining the barbed wire
- Development of Airport Properties
 - o Staff will be working with Jeff Myers.

- RFP-Designer Selection for Chapter 149 Projects
 - o Management is negotiating a contract with the selected firm of Fennick/McCredie
- Development Agreement Update

- Taxiway C Construction
 - o Lawrence Lynch will resume in the spring to finish the P-608 sealant and the repainting.
- Air Service Development and Marketing Update
 - O Staff will not be applying for a SCASD Grant this year, as there is not enough time to obtain community support
 - There was a brief introduction and discussion with a potential airport tenant, Richard Araujo, concerning service to Nantucket. Mr. Araujo gave a brief review of his history in the aviation industry.

 - o A revised RFP will be issued
- Airport De-icing Program
 - o The deicer was being used, but the pumps were not working properly. This is being fixed
- Island Airlines Update

 - o The project will be out to bid this week
 - o The FAA Grant Application must be submitted by May 1, 2016
- Open Meeting Law Update
 - o This will be scheduled after Chairman Persuitte and Commissioner Luzietti return
- Status of Constant Contact Jet Fuel Marketing
 - o This is being worked on by Judith Goetz

Manager Breault mentioned the following:

- Assistant Manager Servis will put together information on the E-ALP program to disperse and schedule a possible presentation to the Commission.
- The Statewide Contract for airfield markings painting is not available this year. So, the Airport is going out to bid to have the work done.
- The recent power failure in Yarmouth caused the Approach lights to not work. These are owned and maintained by the FAA. There is no emergency generator to power them during an outage as this size airport does not rate high enough for the FAA to provide that. The airport is trying to get Eversource to possibly provide power, but they have told staff that there will be a huge engineering cost associated with this. A large generator would be needed to power the lights: 75 to 100kw, 440 power, and 3 phase capacity.
