Approval of the Draft CPC Regular Meeting Minutes from December 17, 2018.

Letters of Intent:

- An updated Letter of Intent has been received from the Barnstable Historical Society located at 3087 Main Street (Route 6A), Barnstable seeking \$113,809 CPA Historic Preservation funds to complete their building repair and improvement project which includes a handicap lift.
 Estimated total project cost is \$162,585 with \$48,750.00 of funds provided by Barnstable Historical Society.
- A Letter of Intent has been received from the Barnstable Historical Commission seeking \$10,000 CPA Historic Preservation funds for their "Barnstable Prioritized Survey Project". This funding request will enable the Barnstable Historical Commission to fund the completion of new Massachusetts Historical Commission inventory forms within the Town of Barnstable. This funding request represents one half of the total project cost of \$20,000, with an anticipated FY19 Survey and Planning Grant from the Massachusetts Historical Commission. The project consists of the performance of survey work (Form B) for approximately 60-100 properties that have been identified as "first priority" in the 2010 Barnstable Historic Preservation Plan.

Applications:

- An Application has been received from the Centerville Historical Museum located at 513 Main Street, Centerville, MA seeking \$38,840 in CPA Historic Preservation funds representing a portion of the entire project cost to replace the roof of the main museum building and adjoining Tin Shop. The museum contains 17,000 irreplaceable historical artifacts that define the history of Centerville and surrounding communities. Continued from December 17, 2018.
- An Application has been received from Orenda Wildlife Land Trust seeking \$290,000 in CPA
 Open Space/Recreation funds to purchase three buildable lots totaling 6.2 acres on Great
 Marsh Road, Centerville. This CP funding request represents a portion of the \$500,000 asking
 price, with Orenda contributing \$170,000 and pledges from neighbors for \$40,000. Orenda
 proposes to retain ownership of the property, with a conservation restriction to the Town of
 Barnstable.

 An Application has been received from Unitarian Church of Barnstable located at 3330 Main Street (Route 6A) Barnstable seeking \$134,281 in CPA Historic Preservation funds representing a portion of the entire project cost to replace the roof on Warren Hall; rebuild and replace the cupola; restore/replace 33 windows; rebuild ramp, retaining walls and foundation at entry; repair hazardous stairways and entry; install a commercial dehumidifier and polyethylene vapor barrier over the soil in the crawl space under the sanctuary.
