- All phases continue to meet and receive approval from the Old King's Highway Historic Commission

- Aunt Sarah's House restriction recorded; additional funds of @\$30,000 still available outside the appropriation; TOB Legal Department determining eligibility on outstanding requests
- Sturgis Library no correspondence has been received; letter to be sent requesting status update / intentions of applicant
