## II REQUESTS FOR DETERMINATION

**Joe Popolo.** Vista pruning and invasive plant removal on bank at 51 Putnam Ave., Cotuit as shown on Assessor's Map 036 Parcel 041-001. **DA-12051** 

A motion was made to issue a negative determination, with standard vista pruning and invasive species removal in consultation with staff.

**Humam K. Sirhal.** Maintain a 4-foot path for seasonal access to paddle boat; erect raised bed garden 8'x 12' at 36 Broken Dike Way, Centerville as shown on Assessor's Map 227 Parcel 080. **DA-12054**

This matter was withdrawn by the applicant.

**Thomas H. Lowell.** Construct and maintain stairs down coastal bank at 135 Putnam Ave., Cotuit as shown on Assessor's Map 036 Parcel 040. **SE3-5017** 

A motion was made to approve the project with special conditions, including notations for a pre-construction site meeting with staff, and for cut vegetation to be replaced in-kind.

Project to take place at Millway Rd., Barnstable as shown on Assessor's Map 300 and 301 Parcels 022 and 064. **SE3-\_\_\_\_** 

A motion was made to approve the project with special conditions, including a finding that the improvement dredging serves a public benefit.
