A. Christian Swenson – 110 Nyes Neck Road East, Centerville **SE3-4995**

Violation of a certificate of compliance ongoing conditions and plan of record by cutting beyond observable grass line(in approved mitigation meadow area) into woody shrub line edge of wetlands. Removal of infested tree and cutting vegetation at edge of pond without seeking approval from conservation staff. Large stacks of wood within 50' buffer in old garden area.
