- Applicant is seeking approval for a vessel that would have a wider beam than the approved width 6'10". The applicant is requesting an additional 17".
- Request is for handicap purposes. The applicant is seeking a vessel that is more stable.
- The approved "width" condition came from the Waterways Committee.
- With motor down the draft is 23".
- Depth isn't the issue it is the beam of the vessel.
- Three Waterways members expressed concern by way of emails
- Commission is not bound by Waterways findings, however the Commission recommends the applicant to go back to Waterways Committee and make a presentation.
- It was recommended the applicant perhaps provide additional information on the handicap issue and stabilization comparison.

A. Patrick H. Carey AND Toscafund LTD – 765 Old Post Rd., Cotuit – Map 073 Parcel 026. Alteration of a wetland resource area - coastal bank (Town) - by cutting trees, shrubs and other vegetation and alteration of a buffer to a wetland resource area - salt marsh and coastal bank (Town) - by cutting vegetation.

John O'Dea, Sullivan Engineering represented the Carey's and Maggie Carey was present.

Issues discussed:

- Town Coastal Bank and 50' buffer to top of bank was cleared of a significant amount of vegetation (trees and shrubs).
- A meadow area was created approximately 4 or 5 years ago. This area is also in 100' buffer to top of bank. The meadow was created by clearing scrub shrub habitat, similar to what was cleared as part of this recent incident. Changes to the meadow area will be included in the restoration plan (i.e., mowing schedule and additional plantings).
- Homeowner admitted to doing the clearing on the bank and 50' buffer.
- Conservation Agent and project engineer will meet to determine the number of trees cut.
- Full restoration of bank and buffer expected by October 31. 2020. If restoration plantings cannot be completed by that date, the homeowner will notify the Conservation Agent of that fact and will, by October 31, 2020, stabilize the site for winter with jute matting and appropriate erosion controls.
