Mr. Sawyer explained that a picture window would be added on the first floor of the house, and he displayed the existing and proposed elevations.

Nancy Clark noted that no one from the public was present to comment.

Nancy Shoemaker reported that she and several other Commissioners had visited the site, and she offered her photographs of the property for Commission files. Elizabeth Mumford noted the exceptional views there and said she approves of the proposed project, and Marilyn Fifield agreed.

Nancy Shoemaker moved, seconded by Elizabeth Mumford, that, in accordance with Section 112-3(F), the Barnstable Historical Commission determines that the proposed partial demolition of the building located at 20 Scallop Path, Osterville, is not detrimental to the historical, cultural, and architectural heritage or resources of the Town.

OTHER

Nancy Clark reported that she and Marilyn Fifield attended the November 2nd Town Council hearing on the proposed demolition of the National Register homes at Sea Captains Row in the Pleasant St.-School St. National Register Historic District. She hoped a Historical Commissioner would attend the next Council meeting, on November 16th @ 7pm, specifically to read the Commission letter dated October 18, 2017. Nancy Shoemaker added that she could provide photographs of the properties.

Nancy Shoemaker read a tribute she had drafted to commemorate the passing of Elizabeth "Betty" Nilsson, formerly a longtime member of the Town's Old King's Highway Regional Historic District Committee.

Elizabeth Mumford reported that her coloring book for the Osterville Historical Society just went to press and may be ready for Thanksgiving, adding that she expects to work on one next for the Sturgis Library in Barnstable Village.

Nancy Shoemaker reported that the Barnstable Historical Society will sponsor its annual Holiday house tour on December 3rd, involving six unique structures.

Nancy Clark thanked Erin Logan and Marilyn Fifield for their efforts in drafting and editing the meeting minutes, and Ms. Fifield noted that Ms. Logan's initial drafting is more challenging, while editing is relatively easier.

Nancy Clark noted that the next meeting would be the last of this year, on December 12, 2017, and Elizabeth Mumford replied that she may not attend.
