A quorum being duly present, Chair Jessop opened the meeting at 6:34pm

- Application reviewed (Exhibit B)
- Sign board material sample reviewed (Exhibit C), aluminum clad exterior grade plywood, high polish white; adhered vinyl lettering proposed
- Mr. Cronin speaks to the suggestion to remove the background on the proposed sign
- Ms. Jenkins states that the applicant was willing to remove the background of the sign if that was the direction from the Commission
- Ms Kenney states preference for removing the background as it would then be more in keeping with the guidelines of the Historic District.

McDonald's Corporation, c/o Ayoub Engineering, Inc., 175 North Street, Map 308, Parcel 075 (continued from July 17, 2013)

Building addition and façade renovation (windows, doors, siding, roof, exterior painting, awning/ canopy, etc); Fence; Signage modification and dual menu board

Represented by Alan Micale of Ayoub Engineering

- Application reviewed (Exhibit E)
- Seeking site modifications to the site to improve the look and operations
- Drive thru side-by-side operation; proximity to intersection makes creating access to High School Road not feasible;
- Studies show a single window is ineffective; intent is for safety and improved operation efficiency
- ADA compliance and accessibility to the building reviewed
- Perimeter of the site will receive additional landscaping
- Proposed plans reviewed; minimal increase to rear section for positioning of second cash window
- Review of proposed materials and elevations
- Signage: proposing removal of @40 sq. ft. sign and replacing with two non-illuminated arches, no other signs on the building proposed

Comments:

- Mr. Cronin: proposed façade on North Street is not in keeping with the historic district; suggests viewing existing materials currently within the Historic District; façade needs adjustment and improvement
- Mr. Arnold: references renovations at a competitor who tore down and rebuilt their structure
- Mr. Micale: clarifies that it is not possible to move the rooftop equipment to ground level due to lack of space; acknowledges concerns expressed by the Commission; reviews proposed landscaping along High School Road
- Ms. Atsalis: the plan lacks aesthetics and is inappropriate for the historic district; requests a dimensional plan for better understanding; requests windows be free of advertising; believes that increased projection of the doors facing North Street is possible
- Chair Jessop: rendering does not show articulation of the wall; suggests extending the walkway to High School Road
 as well; advises pathway to be 5' for proper ADA accessibility; requests clarification on transition between colors and
 dimensional drawings
- Ms. Kenney: suggests bringing back some of the truly historic era McDonald's, i.e. 1940
- Ms. Jenkins: speaks to corporate architecture and the changes made with Burger King, possible suggestions along the façade, i.e. change / break in color as well as foundation landscaping; encourages applicant to investigate other options and colors
- Mr. Macile appreciates Commission suggestions and will review with his team members and identify what could be done to be more appropriate within the Historic District
- Extension of Time Limits signed by applicant

Motion duly made by Paul Arnold, seconded by Joe Cotellessa to continue the application to September 4, 2013, 2013; applicant to provide updated 3-dimensional plans Vote: So voted unanimously
