A quorum being duly present, Chair Jessop opened the meeting at 6:36

An announcement was made by Chair Jessop stating the meeting is being recorded and broadcast on Channel 18 and in accordance with MGL Chapter 30A, §20; and requested that anyone taping this meeting to please make their presence known.

Continued Business

Ramon Morel d/b/a International Barber Shop – 225 Main Street, Hyannis, Map 327/ Parcel 242-001 Continued for re design of signage

Ramon Morel, the applicant in attendance.

Chair George Jessop displays the sign rendering that was submitted (Exhibit A). He describes the revisions made. The dimensions are 24" x 48".

Marina Atsalis comments about having the Greek flag added.

Ramon Morel points out several other countries and the flags that were added.

Motion made by Paul Arnold to approve the new rendition of the sign as presented, seconded by Brenda Mazzeo, so voted unanimously to approve the sign.

Chair George Jessop comments about the trade symbol, the striped barber pole which can be electrified to rotate to indicate open/close of the business. This is a well known symbol. This may be internally illuminated, usually not, but it's a different category.

Ramon Morel states he has ordered a barber pole for display at his place of business and shows it to Board Members via his cell phone (no hard copy picture for file). It is not ready to be displayed as he is waiting to receive the shipment of it.

Motion entertained by Chair George Jessop to approve the barber pole trade symbol, moved by Marina Atsalis, seconded by Paul Arnold, so voted unanimously.

Chair George Jessop states that the trade flag should not be hanging any lower than 7 ft. when over a walking area. A non walking area can have lower than this, i.e., a bench or flower box under the flag then the flag could be lower. The flag size is to be 3 ft. by 5 ft.

Other Business

Motion made by Paul Arnold to approve the minutes of July 16, 2014, seconded by Brenda Mazzeo, so voted unanimously.

Election of Officers; Chair, Vice Chair and Clerk.

Motion made by Brenda Mazzeo to defer the Election of Officers, seconded by Paul Arnold, so voted unanimously

Motion made by Brenda Mazzeo to adjourn, seconded by Marina Atsalis, so voted unanimously to adjourn.
