Jake Dewey, 39 Pearl Street, Hyannis - Map 308 Parcel 089 New Buildings

Jake Dewey in attendance. He gives an explanation of the project, behind Sturgis Charter school. Previous historic bldg.. burned down. Partial town parking lot. To develop 5 new structures, similar to High School Rd. Parking on side and parking in back. Grey siding, wood or wood composite siding, white windows, probable to come back in the future to do solar panels on the roof.

Chair Cheryl Powell clarifies the date of bldg. that burned down. Jake Dewey, replies 2011.

Elizabeth Jenkins shares the screen to show the renderings submitted for the buildings, Exhibit A. Jake Dewey reviews with the Commission. Rear and front facing elevaions. Wood Fencing around the back. Site Plan.

Chair Cheryl Powell asks for any public comment. None. Chair closes public comment.

Betsy Young refers to aerial view, is parking off Pearl Street? Where to come in for parking?

Jake Dewey replies, on Pearl Street, that is the required opening for Fire Dept. A tree on southerly and northerly corners put in.

David Colombo asks how do these buildings differ from High School Rd. buildings?

Jake Dewey replies, they are exactly the same, except stoop in front and the fencing is around a smaller area.

David Colombo thinks good job on High School Rd. project.

Elizabeth Jenkins states that Staff did work with Mr. Dewey to keep the street scape appearance on Pearl Street, pleased how turned out. Did great job on High School Rd. project as well.

Chair Cheryl Powell clarifies that HHDC only gives approval on the exterior look.

Elizabeth Jenkins replies that architectural exterior appearance of the structure is the purview of this Commission.

David Colombo states that HHDC reviewed the High School Rd. project, went over the details, materials same.

Jake Dewey confirms yes, exactly the same, colors, materials.

Betsy Young thinks looks good. High School Rd. is good looking and blends well. Looking forward to more residential housing near Main Street.

David Colombo states that landscaping maintained at High School Rd. as well and this is a good job.
