
Town of Barnstable Old King's Highway Historic District Committee

A quorum being met, Chair Richard called the hearing to order at 6:30 pm. The Chair explained the hearing and appeal process and invited the public to address the Committee and view the plans of interest when the application is called.

Foster, Austin & Diane, 1834 Main Street, West Barnstable, Map 217 Parcel 009, Built c.1858, Inventoried, Contributing Building on the National Register (addition in 1992)

Install storm door

Represented by: Dianne and Austin Foster

Chair Richard confirmed with the applicant that they wish to install a full view aluminum storm door.

Motion duly made by Carrie Bearse, seconded by David Munsell to Approve the Certificate of Appropriateness (Exhibit A) for Austin & Diane Foster, of 1834 Main Street, West Barnstable, Map 217 Parcel 009, Built c.1858, Inventoried, Contributing Building on the National Register, to Install a storm door as indicated on the plans submitted.

Berry, Dana & Debra, 1990 Main Street, West Barnstable, Map 217 Parcel 015, Built c.1960, Inventoried Replace four windows

Represented by: Cape Associates, Brendon Lowry, Dana & Debra Berry

Lowry confirms they are replacing existing windows on the second story. The home currently has eight over eight on top, six over one on the bottom front and the rest of the house (rear and sides) are one over one. He notes it would be a challenge to get six over six to match below.

Bearse asks if there were grills on the windows that had been removed.

Ms Berry advises that the house was purchased with no grills and further there were no grills found on the premises when she moved in.

Bearse commented that while six over six would be appropriate, given the limited visibility from a public way, she would leave it up the homeowners' discretion.

Chair Paul agrees that they will leave it up to the homeowner, but the window should look appropriate to the window size.

Lowry asks if one over one would be acceptable. Bearse confirms.

Motion duly made by David Munsell, seconded by Lesley Wallace to Approve the Certificate of Appropriateness (Exhibit B) for Dana & Debra Berry, of 1990 Main Street, West Barnstable, Map 217 Parcel 015, Built c.1960, Inventoried, to Replace four windows on the front and side of the home with one over one windows noting the home is well off 6A and there is no visibility from the highway.

Build detached two car garage and addition Represented by: Steve Cook, Cathy & Matt Dillon

Cook gives an overview of the project and notes the addition will be keeping in the character of the existing home.

Chair Richard asks if the shed dormer is original.

Bearse asks if the windows in the house true-divided light now. Cook replies that some of them are.

Garage will have a carriage house style door.

Bearse asks if the garage appear higher than the house. Cook responds that the garage will be a little lower. Though the cupola may make it look a little higher.

Motion duly made by Carrie Bearse, seconded by Lesley Wallace to Approve the Certificate of Appropriateness (Exhibit C) for Catherine & Matthew Dillon, of 1750 Main Street, West Barnstable, Map 197 Parcel 037, to build a detached, two-car garage and addition, as indicated on the plans submitted.

Motion duly made by David Munsell, seconded by Carrie Bearse to Approve the Certificate of Appropriateness (Exhibit D) for Wellington Soares, of 100 Cypress Point, Barnstable, Map 334 Parcel 010/003, to construct a single family home as indicated on the plans submitted.
