RECREATION COMMISSION MINUTES July 6, 2020

I PRELIMINARIES

III SCOTT THOMAS, BHS Athletic Director and DAVID KANYOCK, Director of School Facilities

- David Kanyock
 - a. Once school is out, the Recreation Division is able to use the school fields for their programs and this year is no different. Tennis courts are also able to be used.
 - b. The only school fields that remain closed in the district are the high school fields, per the Superintendent.
- 2. Scott Thomas
 - a. As they moved into Phase 3 on July 6th, per the Governor's plan, they re-looked at the situation as promised and it was decided the fields will remain closed.
 - b. The Governor's new guidelines that came out July 6th in regards to sports were even stricter than previously. The Governor will specify inter-scholastic protocols but for now they remain status quo and are not allowing any pre-season/off-season type of activity on the Barnstable High School campus.
 - c. Stadium Field is not for general use without a Permit.

VI STAFF REPORT - PATTI MACHADO (Handout A)

- 1. Administration
 - a. Staff is working both remotely and in the office. Only full time staff have permission to come into the office.
 - b. Barnstable Adult Community Center staff have been helping with the beach permit applications. Parking Management staff have been helping with the beach permits as well.
- 2. Aquatics
 - a. Beach Parking Permits
 - i. Available by mail in, a drop box which has been placed outside the front of the HYCC, or via the new online application.
 - b. Hathaway's Pond
 - i. Opened June 27th and is being closely monitored.
 - c. Beach Operations
 - i. June 27th was opening day
 - ii. Safety Officer position was created. Current full time staff received orientation and special deescalation training and are now working on the beaches in this capacity.
 - iii. Lifeguard training drills have presented challenges. With the Covid-19 restrictions, family members have been used as victims in the drills.

3. HYCC

- a. Plan is to open August 17th.
- b. Cape Cod Culinary Incubator provides weekend meals Friday from 4-6pm and are distributing them at the HYCC.
- c. Joe Izzo and Mark Boardley are in regular communication with our users to keep them up to date on what is happening.

 - i. 6 week program starting Monday July 6th.
 - ii. Orientations were held last week.
 - iii. Locations are: Barnstable Community Innovation School, Centerville Elementary School, and Barnstable Intermediate School.
- 5. Youth Commission Lily Beal
 - a. Special meeting was held to discuss putting out a Black Lives Matter Statement. This statement was presented at the Town Council Meeting and read at the Recreation Commission meeting.
 - b. Approval was given to use grant money for the Hidden in Plain Site trailer.
 - c. No Place for Hate they are in the process of putting together a youth group committee to make changes in the Town of Barnstable.
