## Sandy Neck Board Meeting January 11, 2010

A regularly scheduled meeting of the Sandy Neck Board was held on May 11, 2009 at the Marine and Environmental Affairs Division Building at 1189 Phinney's Lane, Centerville, MA. The meeting was called to order at 7:35 pm by Chairman Rich French.

## **Staff Report:**

### Nina Coleman addressed the Board:

- <u>Erosion</u> there was quite a bit of erosion on the beach from the last storm. No fear of breakthrough to the Great Marsh – not a major problem – just a "heads up" for the summer. Changes in elevations. Some piping plover habitat was lost. Also, lost dunes so may have problems with high tides this summer and campers in some areas.
- <u>Cable</u> Cable was placed at the toe of the dune at Trail 1 in the early 1970s for erosion control. It was originally used as submarine netting during WWII in the Chesapeake Bay area. After the war, it was sold for scrap and the town purchased it from a company in NJ. The erosion control worked for a short time but then the cable started puncturing tires and oil pans and after a few storms ended up in a ball which is how it has been for years. The Highway Dept. removed it by using a torch to cut it into sections and then hauled it off the beach. There was approximately 30 tons of cable. (Pictures on file.)
- <u>ORV permits</u> Current 2009 ORV permits are still valid until April 15<sup>th</sup>. The 2010 [renewal] applications will be mailed out in March. New fees for 2010. Resident Permits are \$75. Sandwich Permits are \$115. Non-resident Permits are \$150.

- There was a meeting on December 30<sup>th</sup> with the consultants. Design plans are available. They do not list dollar amounts yet but need draft plans to start the permitting process. Funding has already been allocated.

- On Wednesday, February 24<sup>th</sup> (5:00pm) there will be an informal meeting for the public/neighborhood.

- Tentatively, on Tuesday, March 2, 2010 there will be a Conservation Commission Hearing (joint review with Natural Heritage).
