**Proposal:** Redevelopment of site currently used as a truck transport terminal and trailer and a container sales & rental business, by demolishing existing structure and removing existing uses and equipment, and constructing 2 office buildings consisting, respectively, of 20,018 and 4,900 s.f., together with numerous site improvements including new parking areas, re-designed access/egress, storm-water drainage system, connection to municipal sewer, revegetation of adjoining leased land, and significant landscape improvements. Proposed office uses include approximately 10,000 s.f. of medical office and 14,918 s.f. of professional office.  
*Conditional Use Special Permit will be required from the Zoning Board of Appeals.*

**SPR 026-17** The Cape Cod Five Cents Savings Bank  
**POST CCC** 1520 Iyannough Road and 131 Attucks Lane (Rte. 132)

Zoning: HB, WP Overlay

**Proposal:** Demolition of existing one-story 32,255 s.f. retail building with no basement, plus the 5,904 s.f. two-story building with basement at 131 Attucks Lane; construction of a new, approx. 78,220 s.f. two and one half story office building (inclusive of a retail branch). Also, construction of a two-level parking structure with 99,733 s.f. of raised or covered parking deck to accommodate 240 vehicles. Extensive renovations are proposed to the site entries, parking areas, driveways and landscaping.

For your information the section of the M.G.L. that pertains to postings of meetings is as follows: Except in an emergency, in addition to any notice otherwise required by law, a public body shall post notice of every meeting at least 48 hours prior to such meeting, excluding Saturdays, Sundays and legal holidays. In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located.
