



Town Council Meeting  
June 18, 2020



**The June 18, 2020 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation.**

A quorum being duly present, President Paul Hebert called the June 18, 2020 Town Council meeting to order at 7:02 p.m. from a remote location.

An announcement was made by President Hebert regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by Vice President Rapp Grassetti; followed by a moment of silence.

**PUBLIC COMMENT:**

Janet Davis stated that the federal judge reversed the decision of the Planning and Zoning boards which will mean that the T-Mobile can go forward, we ask the town's legal team to stop the tower, when is enough enough?

Joanne Uchmann stated they begged the town attorney's to hire experts, we offered to pay for half of the fee, we wonder if the town will give up or step up to appeal this decision and stop T-Mobile.

Molly Sproul we are beyond disappointment and the lack of follow through for the citizens of Centerville. It is not an invisible threat; there are nationwide movements against 5G.

Lucas McCauley Chair of Barnstable Youth Commission and Lily Beal the Vice Chair of the Barnstable Youth Commission read a statement to voice their support behind the Black Lives Matter Movement.

Devin Mc Curran concern about the cell tower inside the churches steeple, the radiation that will be emitted, urged the town to do whatever they can to appeal that decision.

John Crow said the Town Councilor's were taking him to task for his public records request. I have the right to ask for these public records regarding the Airbnb shooting, this is one of six homes the owner has removed from sale to use as an Airbnb. The residents

expect all the Councilors to learn all the facts before voting on the items.

Sharon De Francesco spoke against the installation of cell phone towers due to emissions that will affect the people of Centerville. The FCC is allowing cell towers; we should not allow even one more tower into our community.

**Response to public comment:**

Several Councilors thanked the Youth Commission for taking a stance on Black Lives Matter, and shared the concern regarding 5G tower installations.

T-mobile site issue, appreciate the sentiments; part of the problem is that the town has limited ability to do much. We do hear and understand your concerns for towers in the neighborhoods; this is the time to voice your concerns.

**TOWN MANAGER COMMUNICATIONS:**

Update for period June 5, 2020 through June 18, 2020 (Exhibit A)

All necessary steps have been taken to control spending, although the town has continued to work to provide the programs and services to our residents.

Mark Milne: We are using reserves to balance the budget, only 8 percent of our general budget is from the state. We still do not know the extent of the pandemic, but we are well positioned.

**SECTION 1. ORDERED** that the Code of the Town of Barnstable be amended by adding the following Chapter 190, Short Term Rental Properties, to the General Ordinances:

**“CHAPTER 190 SHORT TERM RENTAL PROPERTIES**

**§ 190-1 Purpose**

The purpose of this chapter is to protect the health, safety, and welfare of both the occupants of short term rental units and the general public and to maintain the quality of life in residential neighborhoods and the availability of the Town’s housing stock. It will assist the Town in the enforcement of state and local health and safety regulations and provide a method of correcting violations when requiring immediate attention.

“J. Short term rentals. Notwithstanding any provisions to the contrary in this Chapter 240, short term rentals shall be permitted within lawful dwelling units in all zoning districts. A short term rental shall be defined as a residential dwelling or any portion of a dwelling rented out through the use of advance reservations, for a fee, for a period of not more than 31 consecutive calendar days, excluding: Cottage Colonies, as defined herein; hotels licensed under M.G.L. Chapter 140, Section 6; motels licensed under M.G.L. Chapter 140, Section 32B; lodging establishments licensed under M.G.L. Chapter 140, Section 23 or under Chapter 506 of the Code of the Town of Barnstable; bed & breakfast establishments or bed & breakfast homes licensed under said Chapter 506. Cottage Colony shall be defined as a group of three or more detached dwellings, legally in existence at the time of adoption of this ordinance, located on a single lot, which are customarily occupied on a seasonal basis. When a property is in use as a short term rental, on-site parking shall not be in any cultivated or landscaped area between a roadway and the part of the principal

structure nearest to the roadway.”

**2020-185 AUTHORIZING THE TOWN MANAGER TO EXECUTE A REGULATORY AGREEMENT BETWEEN THE TOWN OF BARNSTABLE AND AIRVIEW, LLC INTRO: 06/04/20, 06/18/20**

**ORDERED:** That the Town Manager is authorized pursuant to Section 168-5, General Ordinances of the Code of the Town of Barnstable (the “Code”), to enter into and execute a Regulatory Agreement between the Town of Barnstable and Airview, LLC, for the properties at 451 and 467 Iyannough Road/Route 28, Hyannis, Massachusetts, and shown on Town of Barnstable Assessor’s Map 311 as Parcels 027, 081 and 082, respectively, consisting of approximately 2.108 acres of land, and which are more particularly described in the deed recorded with the Barnstable County Registry of Deeds in Book 28116, Page 008 (collectively, the “Property”), with the Property having access to Barnstable Road via an easement over the parcel of land located at 400 Barnstable Road, Hyannis; and permitting the redevelopment of the Property and granting the requested zoning relief and approval under Chapter 115 of the Code pursuant to and as described in this Regulatory Agreement.

A motion was made and seconded to amend Order No. 2020-146 by striking \$71,405,234 and inserting in its place \$70,850,919, and by striking \$950,531 and inserting in its place \$396,216.

**Councilor comments and questions:**

Prefer greater reductions in the school department, we cannot know today the effects of the pandemic on our town. Many conversations, want to wish our educators the best in the new environment. What was the rationale for both of the adjustments? [Neary, We looked at how this affects our property owners/taxpayers, we are better off in being cautious in the town’s finances. How did you get the numbers? Is this the only department that has budget increases [Milne, there are a couple of others] Support the children, have been told the school is top heavy, with all due respect, the school superintendent needs to serve by example, trust that the superintendent can figure out a better way; Increase of 1.5 percent? I don’t have the numbers, [Mark Milne, reduces by \$554,315, equals the number from the reserves] [Mayo-Brown, reduction of budget, there is a revenue sharing agreement with the town of 60/40; the School Committee realigned and readjusted to lower the budget] Most of the comments received were for level fund the budget; the town and the schools have to come together in September, to work on the budgets at the strategic planning discussions; especially with the large the number of students leaving the district, [Mayo-Brown, school choice is continuing] What was received and spent on the Cares Act? [Markwell, Barnstable’s allotment \$774,000, which we have to share with the

other schools so we ended up with 600,000 so custodial, busing, etc] Last year we appropriate 69 million, this year is 71 million, we care about the students, there are a lot of unknowns, it makes sense to be a conservative now, this motion does do that, lets not rush the budget, will support this motion; level service budget, additional increases, it is within the 60/40 split, trust between the Town Council and the School Committee, larger issues that we need to address, saw many items on social media, moving forward, we will find we agree on 95 percent. We have to stop the bleeding of children going to other schools, we need to make Barnstable excellent across the board. It's an opportunity to make Barnstable first; we can agree the kids are first. We need a vision, couldn't agree more, lots of challenges, would like to see more information on how we spend the money, and the difference it makes. It is going to cost more money to educate our kids next year. Understand the school budget, happy to do the strategic planning; main concern is the children, remote learning best practices, when and where are the teachers going to get the training? [Mayo-Brown, survey done at the end of April, today's survey was about the satisfaction level for remote learning, our teachers had on the job training; we do want to be prepared]

President Hebert recognized Town Manager, Mark Ells, we are moving into the Municipal Budget, and Enterprise Funds. Within each department are there reductions, we looked for a budget reduction not a level service, a 2.5 percent reduction. The Enterprise Funds vary, however the overall general fund services a 2.5 percent reduction.
