*Discussion continued to work on the discrepancy of boat size and mooring size. It was suggested contacting those with small vessels with excessively heavier moorings, requiring that the boat be moved by their mooring service provider to an area in the mooring field more conducive to the boat size. If it is a temporary situation (having a smaller boat) this would not be necessary.

*The subject of mooring wait list protocols that the committee would like to incorporate in next years mooring regulations. For example: limiting the sign up/renewal period, using the web for processing, indicate boat size on the form as well as indicating if they are interested in obtaining a mooring if offered for the current season.

Mooring and Marina updates. Barnstable Harbor update – the construction crew will be back in March and the floats should go in by April 1st.
