Old Business

Chris Peterson discusses IEC support of a ban on single-service Styrofoam packaging. Discussion is around other Towns on Cape Cod that have passed such a ban. Chris Peterson hands out Town of Orleans Styrofoam ban by-law (see attached) for members to review. Peter Doyle suggests members take under advisement until next meeting.

John Boyle hands out a draft letter addressed to Town Council in support of an application for Green Community Status, and Peter reads his draft version of a letter in support of Barnstable becoming a Green Community. John Boyle shows the members Nantucket Green Community video. IEC members review and edit an advisory letter in support of Green Communities.

Call to Order

Peter Doyle called the **January 13, 2020** meeting of the Infrastructure & Energy Committee (IEC) to order at 5:01PM. The meeting was held in the DPW Conference Room located at 382 Falmouth Road, Hyannis.

Approval of Minutes

Peter Doyle asks for motion to approve minutes of November 25, 2019 Meeting. Motion moved by Derek Vannier to approve the minutes of the November 25, 2019 meeting of the Infrastructure and Energy Committee as written. John Boyle 2nd the motion. All in favor, 1 abstention (Rob Wilson) motion carried.

Old Business

Peter Doyle asks about the election of officers, members request that nominations and voting be put on January 27, 2020 agenda.

Peter reads his draft version of letter in support of Barnstable pursuing Green Community status (see attached). IEC members request that the draft version be sent to each member for review. IEC members will come to January 27, 2020 meeting ready to discuss and finalize. Alison Alessi offers to reach out to Karla Cabral or Madhavi Venkatesan to obtain a status update on their efforts in Town of Barnstable municipal plastic bottle ban, which would eliminate non-emergency single-use plastic bottle purchases by the Town and sale of beverages in single-use plastic containers on town property. Alison will draft a letter supporting a Town of Barnstable municipal plastic bottle ban addressed to the Town Council. Alison agrees to reach out to Elizabeth Jenkins, Planning and Development Department to discuss Vineyard Wind Resiliency funding and eligible projects.

John Boyle states Infrastructure and Energy Committee should support efforts to respond to climate change - both adaption and mitigation. He suggested that we propose to add the following (or similar) language to the Town Council's Strategic Plan as an additional bullet point in the "Environment and Natural Resources Section":

• Support efforts to respond to climate change (both adaptation and mitigation). <u>Adaptation</u> is defined as the process of adjustment to actual climate and its effects and <u>mitigation</u> is defined as human intervention to reduce the sources or enhance the sinks of greenhouse gases.

This bullet could also replace the following (existing) bullet point:

• Support efforts to build coastal resiliency.

John also states the IEC should support efforts towards Green Community designation. John would like to see the energy use database updated to include all of the energy data for the buildings.

Chris Peterson agrees to bring information and examples of commercial Styrofoam bans passed in Cape Cod Towns.

Rob Wilson discusses a draft letter to PJ Kelliher thanking him for the presentation and asking if IEC members could offer assistance such as education, signage, etc. IEC members will take letter under advisement and finalize on at January 27, 2020.

ARTICLE __. ADOPT GENERAL BYLAW, CH. 96 - POLYSTYRENE REDUCTION BYLAW

To see if the Town will vote to adopt Chapter 96, Polystyrene Reduction as follows or take any other action relative thereto:

CHAPTER 96 POLYSTYRENE REDUCTION BYLAW

1. Purpose and Intent

The use and disposal of polystyrene products are proven to have significant negative impacts on marine and land environments of our coastal community, including but not limited to:

- Contributing to the harm of marine and terrestrial wildlife through ingestion and entanglement;
- B. Pollution and degradation of the terrestrial and coastal environments;
- Human risk through exposure to harmful carcinogens used in the manufacturing of polystyrene products; and
- D. Disposal burdens for solid waste collection and recycling facilities.

Therefore, the Town of Orleans seeks to protect its natural resources and the well-being of its residents by prohibiting food or retail establishments from the distributing single-use disposable polystyrene containers, and counterparts, through a phase out period.

Definitions

Single-Use Polystyrene Disposable Containers and Counterparts: single-use disposable products for serving or transporting food or beverages, including but not limited to, take out foods and/or partially consumed meals prepared by a restaurant and/or retail food establishment. This includes, but is not limited to, plates, cups, bowls, trays, hinged or lidded containers, straws, cup lids, and cutlery.

Expanded Polystyrene (EPS): polystyrene that has been expanded or "blown" using a gaseous blowing agent into a solid form.

Polystyrene: expanded and extruded forms of thermoplastic, petrochemical materials utilizing a styrene monomer and processed by any number of techniques including, but not limited to, fusion of polymer spheres (expandable bead polystyrene), injection molding, form molding, and extrusion blown molding (extruded foam polystyrene), sometimes called Styrofoam, a Dow Chemical Co. trademarked form of polystyrene foam.

Food Establishments: any operations, including but not limited to, restaurants, schools, charitable associations, food trucks, farmer's markets, concession stands, and other public
